Van Buren Park Pavilions Nos. 1 and 3 Project

1. RECEIPT OF BIDS

The Charter Township of Van Buren, will receive sealed Bids for construction of the Charter Township of Van Buren **Van Buren Park Pavilions Nos. 1 and 3 Project** at the Office of the Township Clerk, 46425 Tyler Road, Charter Township of Van Buren, MI 48111 until **Monday, January 24, 2022 at 2:00 p.m.**, local time. No Bids will be received after that time. Bids will be publicly opened and read aloud at that time and place.

Project located at 50901 South I-94 Service Drive, Charter Township of Van Buren, MI (mailing address 46425 Tyler Rd, Van Buren Township, MI 48111)

2. SCOPE OF PROJECT

The approximate quantities of the major items of Work are:

- L.S. – Furnish two (2) new 30-x44-foot pavilions, steel columns, and metal roofs.
- L.S. – Installation of two (2) new 30-x-44-foot pavilions, including column footings, structures, and roofs.
- SQ. FT – Installation of new pavilion 4-inch reinforced concrete pads, approximately 3,750 square feet total.
- L.S. – Furnish and installation of modified electric feeders and branch wiring (as necessary) for two (2) pavilions.
- L.S. – Furnish and installation of two (2) new 1-inch water spigot configurations at each pavilion, including all fittings, spigots, casings, and the connection to the existing water system. Field investigation of existing configuration and replace water service leads (as necessary).
- L.S. – Furnish and install SESC measures and site restorations with straw mulch blankets.

3. FINANCING

The Charter Township of Van Buren Township is an equal opportunity employer. This project will be partially funded with federal CDBG funds, and the Contract Documents reflect requirements by that agency.

4. ISSUING OFFICE

Bidding Documents are being issued from Fishbeck's Novi office. Bidders should direct questions and correspondence to that office.

5. EXAMINATION OF DOCUMENTS

There will be no bidding documents available for examination at Fishbeck or Van Buren Township offices.

6. OBTAIN BIDDING DOCUMENTS

Bid Documents will be available commencing **January 10, 2022 at 10:00 a.m.** and must be downloaded from the Michigan Inter-Governmental Trade Network website at www.MITN.info, in order to be listed on the official plan holders list.

Obtaining Bidding Documents from any source not identified herein may result in failure to receive addenda, corrections, or other revisions that may be issued, resulting in bidders being considered non-responsive.

7. BID SECURITY

Bid security in the amount, form and subject to the conditions provided in the Instructions to Bidders must be submitted with each Bid.

8. WITHDRAWAL OF BIDS

Bids may not be withdrawn for a period of **120** days after the actual date of opening thereof. This time period may be extended by mutual agreement of the Owner and any Bidder or Bidders.

9. RIGHT TO REJECT BIDS

The Charter Township of Van Buren Board of Trustees reserves the right to accept or reject any or all bids to waive informalities or errors in the bidding process, and to accept any bid deemed to be in the best interest of Van Buren Township, including bids that are not for the lowest amount.

Sealed bids shall be submitted to the Township Clerk by a date and time specified and shall be marked on the outside "Sealed bid for Van Buren Park Pavilions Nos. 1 and 3 Project." The Township Clerk or her/his designee and one Department Director shall publicly open all bids submitted at the date and time indicated on the request for bids. All bidders shall be notified of the contract award in a timely manner.

10. PREBID CONFERENCE

A pre-bid conference will not be held.

11. ONSITE LABOR

Owner requires that all onsite construction labor be paid prevailing wages (CDBG funding is being used).
