- a. Construction is anticipated to begin during the last week of February or the first week of March 2026 and must be completed by the end of September 2026. The end date is set by the Grants funding the project.

- A. Are There Any SAM.gov Requirements That Must be Met by Bidders?
- a. Yes, subrecipients are required by HUD to have a SAM.gov account.

- a. Card Readers for doors to be provided and installed by Owner Vendor (Motor City Electric)
 - i. The Electrical Contractor is required to provide back boxes, raceways, and cabling for card readers.
- b. Security cameras and associated cabling to be provided and installed by Owner Vendor (Motor City Electric).
 - i. Security cameras do not require power to be provided.
- c. Network equipment (data rack and devices) to be provided and installed by Owner Vendor (Macro Connect).
 - i. GC to provide ¾" plywood backer for equipment to be mounted to.
- d. Cabling for network equipment to be provided and installed by Owner Vendor (Macro Connect)
- e. Wi-Fi devices and cabling to be provided and installed by Owner Vendor (Macro Connect)
- f. GC is required to coordinate with Owner Vendors to complete the scope of work outlined in this response.

C. Is Door 101 Intended to be Aluminum or Hollow Metal?

- a. Door 101 is intended to be part of the aluminum storefront system.

D. Should bidders include an allowance for Permit fees?

- a. The City of Ferndale will waive permit fees for this project. However, an allowance of \$4,000 should be included by bidders to cover a potential third-party review.

E. Are winter conditions required?

- a. Bidders are to include winter conditions if it is necessary to complete the work per the schedule listed in the previous question.

F. Please clarify Fire Alarm Scope.

- a. Fire alarm is not needed for this project.

Item No. 9

G. Please Clarify Interior and Exterior Signage Scope.

- a. Bidders are to assume the following two words for the exterior individually mounted letter signage - "Concessions" and "Restrooms".
- b. Bidders are to assume the following interior signs will be provided and installed as part of the project:
 - i. 3 Toilet Room Signs
 - ii. 8 General Room Signs
 - iii. 3 'Exit' Room Signs
